This session will discuss common regulatory issues that Tribal Gaming Regulatory Authorities ("TGRA") will encounter in gaming facility and/or expansion financing transactions. These issues include declination letters, licensing considerations for lenders and contractors, loan transaction details such as length of term, full faith and credit provisions, management, sole proprietary interests, and distributions to the Tribal government. Although TGRAs are not often parties to these transactions, the TGRA's review of the contract documents, licensing requirements, and understanding of the financing structure is vital to effective gaming regulation.
